**Buttermilk Falls:** Develop plan for Invasive removal. The town has funds to be used for invasive removal. A schedule needs to be addressed for continual maintenance.

**Action Item:** Shelley to contact arborist for estimates.

**Action Item:** Susannah to contact tree wardens Matt Klimkosky and Star Childs.

**Action Item:** In April NCC to mark trees to be removed

**Village Green:** Nothing new.

**Invasive Plants:** Joint project with the Land Trust and school.

Hartley met with Botelle principal, proposed "Good Plant/Bad Plant" talk with students.

**Action Item:** Bill to contact Hartley regarding invasive talk at school.

**Pollinators:** The idea of placing an ad in the Norfolk Now requesting volunteer to maintain the Botelle pollinator garden was put forth.

**Plant exchange:** June Farmers market - tentative date June 24th.

**Launch NRI:** In June.

**Norway maple removal project at Congregational Church:** NCC will supply as promised some native maples to replace the Norway maples. Also NCC will supply some native perennials at the time of the invasive plant exchange.

**New Business:** Shelley to take over outreach via Facebook from Susannah.

**Action Item:** Shelly needs to be confirmed as an Administrator.

**Town removal of roadside ash trees:** Raised issue of ash removal scheduled for this year throughout town. Concerns raised about cutting of trees during nesting season and whether there are tree removal firms that would be more environmentally aware.

**Action Item:** Shelley to call Northwest Conservation District re possible companies that do better work.

**Action Item:** Susannah to get from Matt what the plan is and to push for no logging in nesting season for birds.
